

# **KLASSY K-9 & SASSY KAT RESORT & SPA**

## **BOARDING CONTRACT**

The following represents a contract between Klassy K-9 & Sassy Kat Resort & Spa (hereinafter known as KK9SK) and the Owner of the pet(s) whose name(s) appears on this "Agreement." Owner agrees to pay the rate for boarding, grooming and/or delivery or any other services in effect on the date of pick-up. Owner agrees to pay for any unexpected expenses incurred during the stay which were not anticipated such as veterinary bills, the purchase of additional "special" food or other items required by the pet(s). Normal wear and tear is expected owner agrees to pay for any excessive damage to suites or property caused by your pet during their stay.

Owner further agrees that all boarding shall be paid in full on the date of pick-up.

I understand and agree that if I fail to pickup my pet(s) up on the departure date that my pet(s) may be moved to another room or kennel within the facility to accommodate previously made reservations by other KK9SK clients.

Should my pet(s) vaccinations expire while boarding, KK9SK is authorized to take my pet to a Veterinarian and I agree to pay all veterinary charges and any fees charged by KK9SK for this service.

I understand that KK9SK is a "Flea Free" facility and my pets will be given a flea treatment upon arrival at the kennel if fleas are seen on pet. The fee for this is \$6.50 per pet.

At KK9SK the security and care of your pet is the cornerstone of our business. **FOR YOUR PROTECTION** only the Owner of the person listed as the authorized pickup person will be able to pick up the pet(s). Please list any other persons you authorize to pick up your pet in the section located on the Pet Information Sheet.

I understand the hours of operation are: Monday through Friday 8:00 a.m.-5:00 p.m. Saturday and Sunday is for scheduled drop-offs and pickups only. Check out is 12:30 p.m. Pets not picked up by 12:30 p.m. will be charged a day care fee of \$15-\$20. Sunday pickups are charged for a full day regardless of pick up time.

I understand and agree that KK9SK cannot be responsible for lost or damaged bedding or any other items that may be brought for my pet(s). While KK9SK does its very best to care for my pet, I understand that the health of my pet during its stay cannot be guaranteed. Some conditions are unavoidable in boarding facilities such as, but not limited to, hair loss, upper respiratory infections, bronchitis, diarrhea, and parasites. I understand that all pets admitted must be protected against communicable contagious diseases and must be free of parasites.

I understand, by agreeing to the terms of this agreement I hereby authorize and request that accurate vaccination records be provided to KK9SK by my Veterinarian. This information is to be delivered to KK9SK for their records upon their request.

If any problem or emergency develops that it becomes necessary to provide veterinary services for my pet, KK9SK is authorized to obtain veterinary services for my pet(s). I agree to pay all fees and charges for any and all services provided.

I understand the conditions for boarding my pet(s) at KK9SK and by agreeing to the terms of boarding, I am agreeing to hold KK9SK, its owners and employees harmless from any and all claims for damages or injuries suffered by, or in any way relating to my pet(s) stay at Klassy K-9 & Sassy Kat Resort & Spa.
